Dedication and Adoption of Roadways, Swarland

Dedication of roadways at Swarland to allow for their adoption, facilitating maintenance and improvement.

4. RECOMMENDATIONS

In accordance with the authority delegated to the Director of Finance it is recommended that the roadways in Swarland (as shown on attached plan) are dedicated as highways and then adopted by the County Council to facilitate their improvement and maintenance.

5. BACKGROUND (including options and reasons)

Swarland has a large number of un-adopted roads which were historically owned by the Treasury.

Northumberland County Council has come under pressure to improve the roads and recently purchased the title to them.

In order to ensure that the roads are brought up to, and then maintained at, an acceptable standard, the land acquired by NCC (as shown on the attached plan) needs to be dedicated as highway land, which in turn will allow the roadways to be adopted as highways.

It is proposed that the land acquired is dedicated as a whole and then adopted section by section. Over a period of time all of the roadways acquired will be brought up to and maintained at a satisfactory standard.

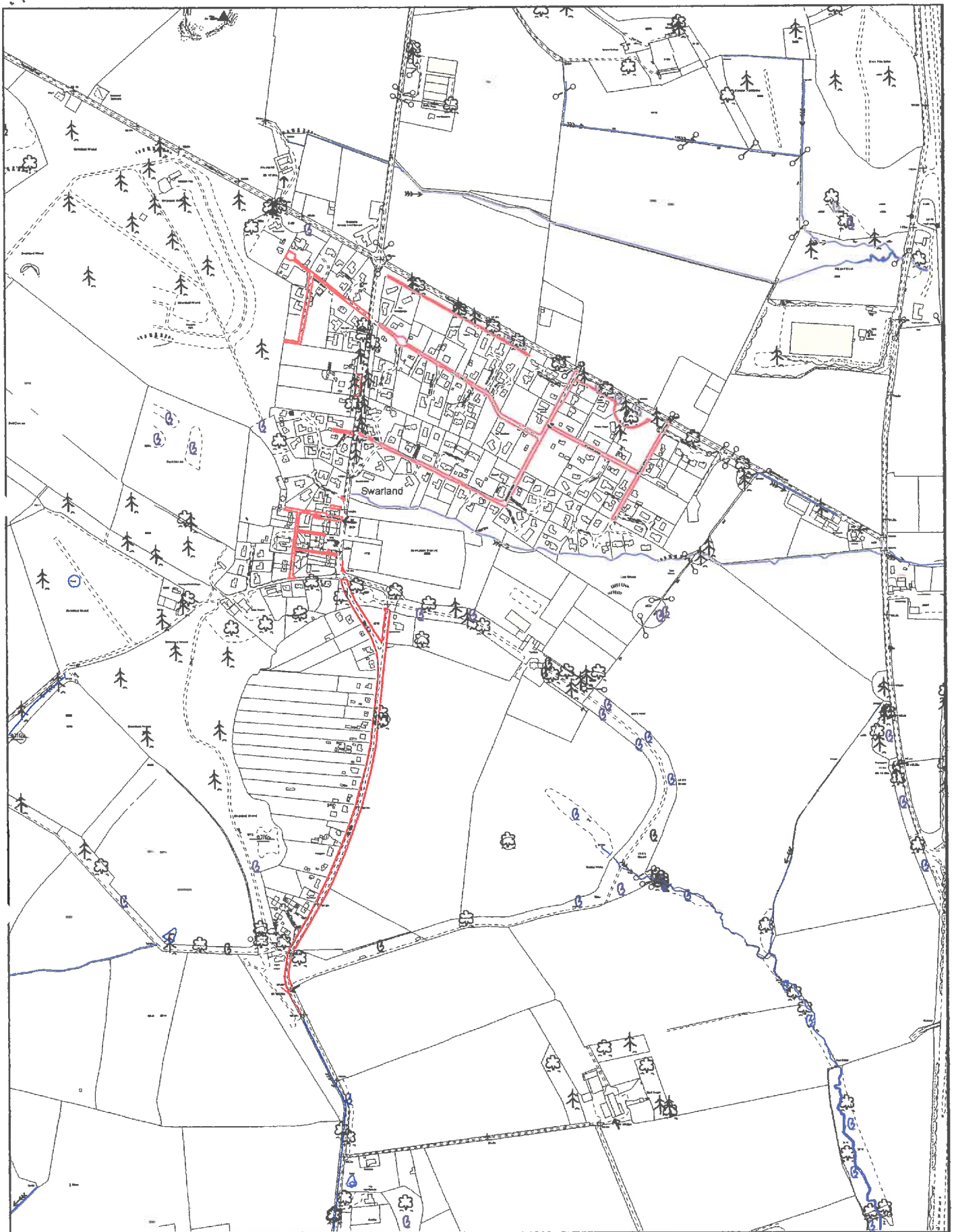
